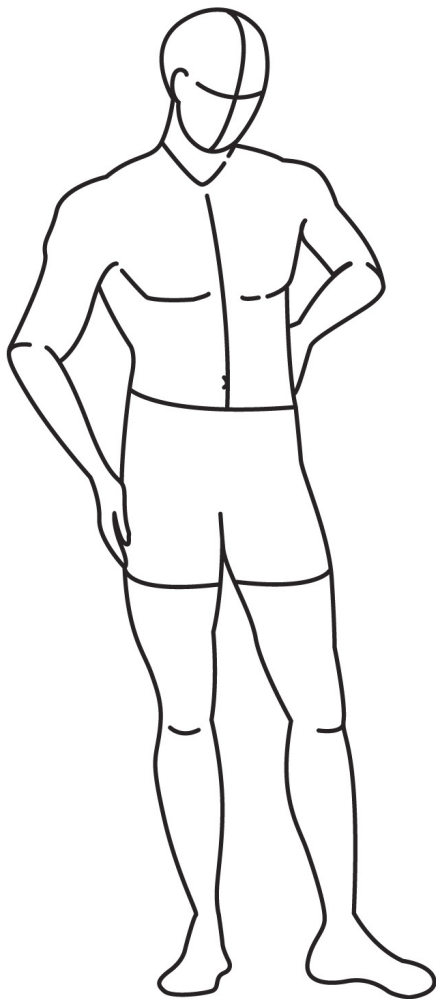

GAYLORD ROCKIES CIRQUE: SPIRIT OF CHRISTMAS COSTUME ART CONTEST OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN

- 1. Contest Period:** Gaylord Rockies Cirque: Spirit of Christmas Costume Art Contest (the "Contest") starts November 2, 2022 at 12:00 a.m. Mountain Time ("MT") and ends November 18, 2022 at 5:00 p.m. MT ("Contest Period").
- 2. Eligibility:** Open to legal U.S. residents, residing in Colorado, who are 18 years of age or older as of date of entry and are parents/legal guardians of child(ren) between the ages of 5 and 12. Employees of the Gaylord Rockies Resort (the "Sponsor"), Don Jagoda Associates, Inc., their respective affiliates, parents, subsidiaries, divisions, suppliers, distributors and advertising, promotional and judging agencies (collectively, the "Sponsor and its Administrators"), and its affiliates and each of their respective employees, shareholders, directors, officers, members, assigns and agents and their immediate family members and/or those living in the same household of each are not eligible to win. Void outside of Colorado and where prohibited by law. Contest is subject to all applicable federal, state and local laws.
- 3. How To Enter:** During the Contest Period, parents/legal guardians of child(ren) between the ages of 5 and 12 may enter by completing the Contest entry form (the "Entry Form"), which includes a template where the child must draw a holiday-themed costume (the "Entry"). All mailed Entries must be postmarked by November 18, 2022 and received by November 21, 2022. Emailed entries must be received by 5:00 p.m. MT on November 18, 2022. Any Entries received before or after the designated Contest Period will be disqualified. The parent will be deemed the entrant (the "Entrant"). The Entrant must be the parent/legal guardian of child(ren) whose artwork is depicted in the Entry. The Entry must: 1) be complete to be eligible; 2) be the property of the Entrant. Sponsor has the sole discretion to determine whether a submission qualifies as an Entry. Any Entry not in compliance with the above and which does not meet the requirements of these Official Rules will be disqualified. Limit one (1) Entry per child.

4. Entry Requirements, Representations and Warranties:

You acknowledge and agree to the following with respect to each Entry you submit: By entering, you agree to waive any rights you may have to the Entry submitted. Entries become the property of the Sponsor and will not be acknowledged. Entrants and winner acknowledge and agree that their Entries become the property of the Sponsor, which thereby has the right to edit, adapt, modify, reproduce, promote and otherwise use Entries in any way it sees fit. Any Entry not in compliance with the above and which does not meet the requirements of these Official Rules will be disqualified.

- Entry must be in English, but may also include other languages.
 - Entrant must be the parent or legal guardian of the child's whose drawing is depicted in the Entry.
 - The child can use any form of media (crayons, markers, paint, colored pencils, etc.)
 - The Entry, or portion thereof, must not contain obscene, profane, lewd, defamatory or inappropriate content, or be disparaging to Sponsor, as determined in Sponsor's sole discretion.
 - Entry must not, and you represent and warrant that it will not, violate or infringe any third-party copyright, trademark, trade dress, logos (excluding Sponsor), or other proprietary right of any entity or person (living or deceased), including, but not limited to rights of privacy, publicity or portrayal in a false light.
 - Entry must not make reference to any commercial/corporate advertising, including but not limited to corporate logos, brand names (other than Sponsor's), slogans, political, or religious statements, or be otherwise objectionable.
 - Entry must not include any representation or likeness of celebrities, athletes, musicians, or any other public or private figure (living or dead unless you have express permission), any commercial solicitation or promotional materials or last name, address, phone number, or URL address.
 - Entrants and all submitted Entries must be in keeping with the image or message of the Sponsor in its sole discretion, or Entry will be disqualified from the Contest.
 - You must own all rights in the Entry and have the right to grant Sponsor a license to use the Entry (including any material embodied in the Entry).
 - Any Entry deemed inappropriate or unsuitable, in Sponsor's sole discretion, will be rejected during the screening process. Entry must be suitable for a family/general audience.
 - Entry must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation or age.
 - The Entry cannot defame, misrepresent or contain disparaging remarks about Sponsor and its Administrators or their products or other people, products or companies.
 - Entries must be created during the Contest Period.
 - Entry must not contain content that is known by you to be false, inaccurate or misleading
- 5. Winner Determination, Judging and Winner Notification:** All Entries will be judged by Sponsor-selected judges ("Judges") on or about November 22, 2022 based on the following criteria: Creativity (40%); Originality (30%); and Adherence to Theme (30%) (the "Judging Criteria"), to determine one (1) Grand Prize winner. Any tied Entries will be re-judged by the judges based 100% on Creativity to determine the winner. The potential Grand Prize winner will be notified by email and will be required to sign and return, an Affidavit of Eligibility and liability and publicity release and assignment of rights ("Affidavit"), except where prohibited, within three (3) days of notification attempt or prize may be forfeited and an alternate winner may be determined. If the potential Grand Prize winner fails to return the completed Affidavit within two (2) days, or if affidavit is returned as undeliverable or if the potential winner is deemed ineligible, an alternate potential winner may be determined. Winner's guests (or winner on behalf of minor guests who are their child/charge) must execute and return a release of liability prior to use of prize. Judges' decisions are final with respect to all matters relating to the Contest. By participating, Entrants agree to the Official Rules and the decisions of the Judges, which shall be final and binding in all respects.

There is no retail value associated with the feature. All details of feature is in Sponsor's sole discretion. Prize is awarded "as is" without any warranty or guaranty of any kind, and tickets are subject to all of the ticket issuer's terms and conditions. No substitution or transfer of prize permitted except at the sole discretion of the Sponsor who reserves the right to substitute prize (or portion of prize) of equal or greater value in the event the prize is unavailable. Tickets must be used on December 10, 2022 and the overnight stay must be used on either December 9, 2022 or December 10, 2022 or prize will be forfeited. The Grand Prize winner is solely responsible for all taxes in connection with the prize, including without limitation federal, state and local taxes, and the reporting consequences thereof. The Grand Prize winner will be issued a 1099 tax form for the actual value of prize.
 - 7. Winner assumes all liability for any injury or damage caused, or claimed to be caused by participation in the Contest or use or redemption of the prize. Entries will be declared to be made by the authorized account holder of the email address associated with the Entry, if applicable. Sponsor reserves the right to cancel, terminate or modify the Contest if it cannot be completed as planned for any reason, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, technical failures or corruption of any sort. In such event, Sponsor will award the prize from eligible Entries received prior to cancellation based on judging criteria as outlined above. As a condition of entering the Contest, Entrant agrees that: 1) under no circumstance will entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, punitive, incidental, consequential or any other damages; 2) all causes of action arising out of or connected with the Contest, or prize awarded, shall be resolved individually, without resort to any form of class action; and 3) any and all claims, judgments, and award shall be limited to actual out-of-pocket costs incurred, but in no event will Entrant be entitled to receive attorneys' fees or other legal costs.
